**RENOVATION OF AISBOF BHAVAN AT MUMBAI  
AND REVISED MAINTENANCE CHARGES**

We are pleased to inform that the AISBOF Bhavan located at Royal Apartments, Sion West, Mumbai, has undergone extensive renovations for the enhanced comfort and convenience of our members and their families. The refurbishment includes upgraded facilities and amenities to ensure a pleasant stay for all occupants.

In light of these improvements, we would like to bring to your attention the revised maintenance charges for the rooms at AISBOF Bhavan:

1.	Double bed with non-attached bathroom	` 1000/- per night
2.	Double bed with attached bathroom	` 1200/- per night
3.	Triple bed room with attached bathroom	` 1500/- per night

Additionally, we recognize that many of our members and their families avail themselves of accommodation at AISBOF Bhavan while undergoing cancer treatment. In acknowledgment of the extended duration of their stay and the challenges they may face,

we have decided to offer a concession of 25% on the maintenance charges for those members who are visiting for a prolonged duration exceeding 10 days.


This concession aims to alleviate some of the financial burdens associated with prolonged medical treatment and to provide support to our members during difficult times.
