PERMANENT FULL TIME/PART-TIME MEDICAL OFFICERS: UNIFORM TERMS & CONDITIONS OF SERVICE (UTCS)

We quote hereunder the text of **AISBOF Circular No. 14 dated 19.03.2012** on the captioned subject, the contents of which are self-explicit.

TEXT

"We have been following up with the Management for uniform terms and conditions of service (UTCS) to Medical Officers. We are glad that Banks has come out with improvements / modifications, in the service conditions of Banks Medical Officers as detailed below.

(i) Relaxation in post qualification experience in case of post graduate degree:

Existing	Revised
Minimum 5 years as a general practitioner reckoned from the date of registration with Medical council (Experience gained during internship not counted for eligibility)	, ,

(ii) Reimbursement of entertainment allowances may be introduced with the Financial year 2012-13.

(iii) Other existing facilities/perquisites in terms of eligibility and amount, which they are already drawing, may be brought in line with general cadre officers (non-budgetary and non-operational). The matching pattern of medical officers vis-à-vis general officer for the aforesaid purpose is mentioned as under:-

Reimbursement of expenses towards transport of personal effects on transfer (w.e.f. 1.4.2012)		Medical officers will be eligible to claim Reimbursement of expenses towards transport of personal effects on transfer on the same terms & conditions, as applicable to general cadre officers of respective grade, as mentioned above.

	The above Authority and positions would be the same as applicable to general cadre officers of respective grade, as mentioned under: PPMO-IPPMO-I<> JMGS-IPPSMO-II<> MMGS-IIPPSMO-III<> MMGS-IIIPPSMO-III<> SMGS-IVChief Medical Officer<> SMGS-V		

(v) The full time medical officers will be eligible for leased accommodation facility and consequently provision of furniture along with monthly reimbursement of cleansing charges, casual labour on the same terms and conditions as applicable to general cadre officer of respective grade as mentioned above.

- (vi) Other existing instructions in respect of following facilities to medical officers shall remain the same:
 - (a) Medical facilities and definition of family/dependents for the purpose of extension of medical facilities
 - (b) Definition of family for the purpose of Leave Fare Concession
 - (c) Salary and allowances (dearness allowance and city compensatory allowance)
 - (d) Consultation and visiting fees

- (e) Loans and advances
- (f) Leave encashment on retirement
- (g) Appointing authority
- (h) Conduct and discipline
- (i) Transfer and posting
- (j) Provision of locum doctor
- (k) Pension, Provident Fund and Gratuity
- (I) Non-practicing allowance to full time medical officers
- (m) Privilege leave
- (n) Sick leave
- (vii) The medical officers shall not be entitled to any other facility/allowance other than those mentioned above.

3. Affiliates may please note the above said improvements and advise medical officers (on Permanent Rolls of the Bank) to be guided accordingly."
