SALARY REVISION FOR MEDICAL OFFICERS

The permanent, full time/part time Medical Officers in our Bank are governed by uniform terms and conditions of service. They were fitted in the Pay scales of officers along with other officials' w.e.f 01.02.1984, during the 5th Bipartite settlement. Subsequently, their scales were not revised, during 6th Bipartite w.e.f 01.11.1992, instead the effective date was postponed to 01.03.1995. Thus they were deprived of revised scales for about 28 months.

2. The next revision took place with a gap of 5 years, w.e.f. 01.03.2000 and 01.04.2005. Ever since, these Medical Officers have been requesting for a retrospective revision to compensate the postponed period of the settlements in 1992/1995.

3. As a one-time measure, we requested our Management to consider their genuine grievance and extend the 9th Bipartite Revision to Medical Officers, also w.e.f 01.11.2007 as a special case. Their next revision may be considered along with Industry level settlement w.e.f 01.11.2012. This will remove disparity in periodicity of revision of salary and allowances for Medical Officers.

4. We are glad that Management has agreed to our request and the ECCB in its meeting held on 30.09.10, has decided to extend 9th bipartite scales to Medical Officers, w.e.f 01.11.2007. There are improvements in reimbursement of certain expenses and automatic movement from one scale to the other etc. With this a long pending demand of Medical Officers has been accepted by the Management. We congratulate our Medical Officers and thank the Management for considering our request.

5. A detailed official communication is awaited.
