**FRATERNAL SUPPORT TO ONE-DAY NATIONWIDE GENERAL STRIKE ON 12<sup>th</sup> FEBRUARY, 2026**

You are aware that a strike call has been given by AIBEA, AIBOA and BEFI in support of the call given by the Central Trade Unions for a One-day Nationwide General Strike scheduled on 12th February 2026.

The proposed strike reflects the growing concern and anxiety among employees regarding various Government policies perceived to be detrimental to workers' interest. Such apprehension crops on account of introduction and implementation of the four Labour Codes without adequate consultation with stakeholders, causing trust deficit and impending dilution of established labour protections, collective bargaining mechanisms and the independent functioning of trade unions. Further, issues relating to privatisation of Public Sector Banks, disinvestment measures and policy directions that undermines the role of developmental and institutional character of the banking sector have intensified concerns among bank officers and employees.

In this backdrop and in solidarity for the cause of larger trade union movement, the All-India Bank Officers' Confederation (AIBOC) extends its fraternal support to the Nationwide General Strike on 12.02.2026 and vouch for a whole hearted participation of all the programmes chalked out by the participating organisations including social media campaign, badge wearing and demonstrations at various centres.
